I agree to work assignments through Icon Models & Talent, under the terms and conditions listed below. I will work on a flat rate basis and such rates are quoted to me and are validated in writing prior to job performance through the agency's Talent Contract Sheet.

I understand that employment and compensation can be terminated, with or without cause or notice at any time at the option of Icon Models & Talent, or the client on an assignment. No representative of Icon Models & Talent other than the managers of the corporation has authority to enter into any agreement for employment for a specified period of time or to make any agreement contrary to the foregoing.

I agree that I shall not work for any current Icon Models & Talent account on a free lance basis or through another agency if I have worked or auditioned, in whatever capacity, for that account while under the terms of this agreement. This includes accounts in all areas of the industry such as trade shows, promotions, videos, photo, fashion, commercial bookings etc. for a period of twenty-four months. I further understand that legal action may be taken against me if I should violate these provisions.

I understand that I will be an independent contractor of Icon Models & Talent and responsible for the completion of all necessary tax forms etc.

I further understand that I, as a professional model/actor, know not to chew gum, drink alcoholic beverages, solicit accounts, enter into personal social relationships with the client, smoke or talk unnecessarily to passersby during the time I am employed. This applies during any vacant times, breaks, lunch, and dinner or while performing an assignment. I also understand the importance of being on time for any booking and that if I arrive late to an assignment, I will be penalized monetarily.

If the talent is a minor – the undersigned parent does hereby warrant that prior to the model/actor doing any work during normal school hours, that they shall receive an excuse from attendance from their respective school district, and hereby hold harmless Icon Models & Talent from any liability due to failure to do so.

I agree to grant the rights to Icon Models & Talent to use my likeness in connection with the company's web site for the purpose of booking clients. I agree to release Icon Models & Talent from any claims for further compensation in connection with such use.

I also grant the use of the rights of any materials supplied by the undersigned to Icon Models & Talent will not violate the rights of any third party. The undersigned shall indemnify and hold Icon Models & Talent, its officers, agents, and consultants harmless from any demand, claim, action, liability, personal injury and expense (including reasonable attorneys fees) arising out of the usage of the undersigned's likeness.

This agreement shall be construed and enforced in accordance with the laws of the state of Nevada. Any action, law or other judicial proceeding for the enforcement of any provision of this agreement shall be instituted in the courts in the county of Clark, State of Nevada.

In signing this agreement, I agree that all information printed here has been read and understood by me and/or my legal guardian, and that the information provided by the undersigned is true and complete and that any misrepresentation, falsification or willful omission may be sufficient reason for refusal of employment or dismissal after employment.
